**Secretary:** Minutes for April, 2016 meeting were posted on the Parish Web Page for review following the last meeting. Jon Branca motioned to accept the minutes as written, Angelo Cinti seconded and members approved.

**President:** HNS President, Ernie Poirier addressed the Holy Name Society on the following topics:

1. The HNS President requested that the HNS make payment on the following donations:

\$442 for First Holy Communion

\$300 for Confirmation

It was also requested that a \$300.00 donation to St. Vincent DePaul Society be paid prior to July 1<sup>st</sup>, 2016. Angelo Cinti motioned to make the payments, Tom Lyons seconded and members approved.

2. The HNS President requested that the HNS raise its donation to Good Counsel Homes from \$200.00 to \$300.00 while lowering the funding for the Easter Egg Hunt and eliminating the donation to the Sports Committee. All approved.
3. The HNS President placed a Thank You note in the Weekly Bulletin for the parish's generous support of the HNS Mother's Day Flower Sale. An additional insert will highlight our HNS fund raisers, how the funds help our parish and community and an invitation to the men of the parish to join the HNS.
4. The HNS President raised the question as to whether the HNS Easter Egg Hunt should be eliminated from our list of activities.
  - a. Jerry Satkofsky, the Easter Egg Hunt chair, stated that the egg hunt attendance has been low for the first two years and that the funding could be better used to promote other children's activities within the parish.
  - b. Angelo Cinti stated that many parents appreciated the egg hunt and that additional advertising could bolster the turnout.
  - c. It was agreed upon that the HNS would continue to promote the Easter Egg Hunt for a third year.

**HNS Dinner:** Angelo Cinti updated the Holy Name Society on the upcoming HNS Dinner. The food selection will include: Bratwurst, kielbasa, Italian sausage and a variety of condiments.
